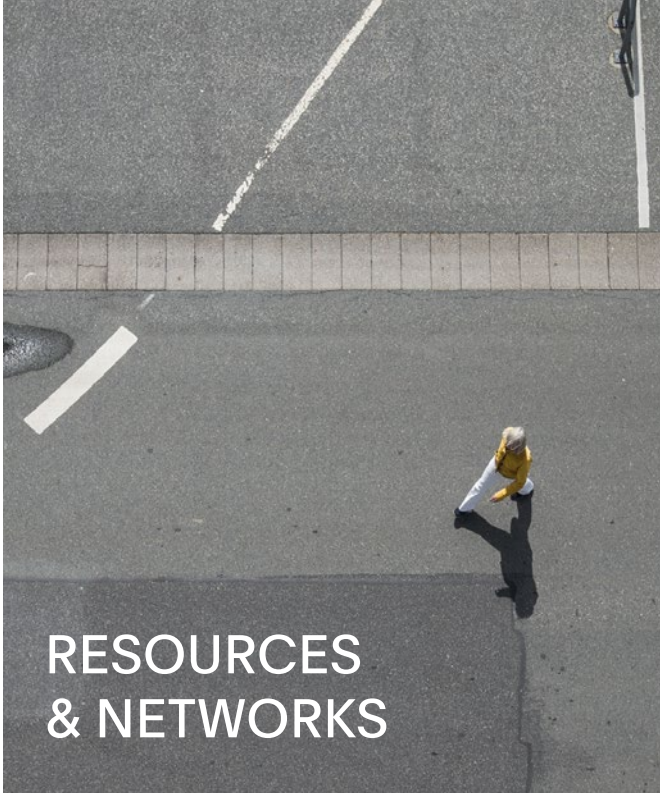

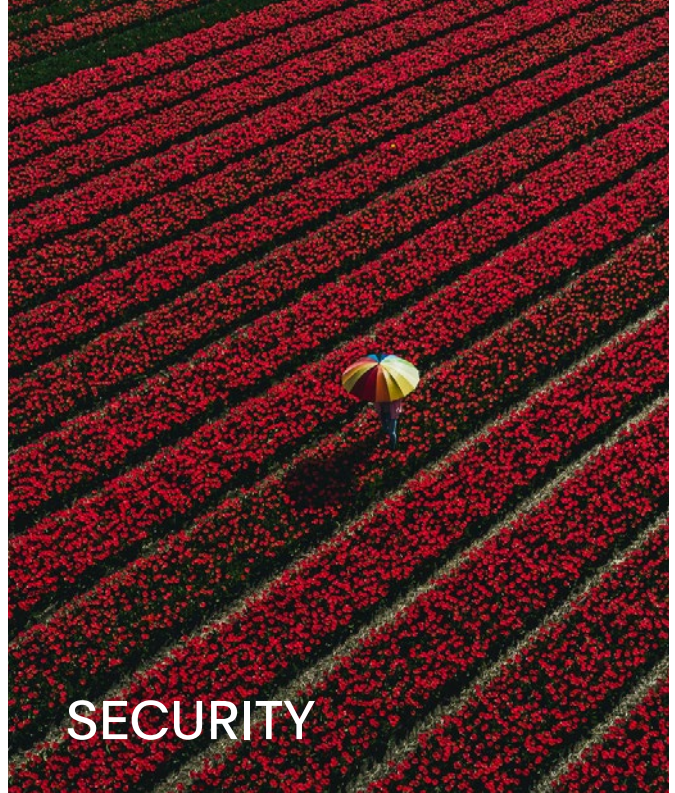

INCOME PROTECTION
